Appeals

If a zoo operator is aggrieved by a decision made by North Devon Council to refuse to transfer a zoo licence a person can apply to the magistrate's courts within 28 days of receiving notice from the Local Authority. The magistrates can confirm the Local Authority decision, vary it or reverse the decision.
