ENFORCEMENT NOTICE

OPERATIONAL DEVELOPMENT

TOWN AND COUNTRY PLANNING ACT 1990 (as amended by the Planning and Compensation Act 1991) ("the Act")

ISSUED BY: North Devon District Council ("the Council")

THIS IS A FORMAL NOTICE which is issued by the Council because it appears to it that there has been a breach of planning control, under Section 171A(1)(a) of the Act, at the land described below. The Council consider it expedient to issue this notice, having regard to the provisions of the development plan and to other material considerations.

2. THE LAND AFFECTED (shown edged red on the plan attached)

Land at 6 Wimborne Terrace, St. George's Road, Barnstaple, Devon

("the land")

3. THE BREACH OF PLANNING CONTROL ALLEGED

The unauthorised erection of a metal frame structure extending from the rear of the residential dwelling on the land forming a balcony area, staircase and covered car parking area, shown for identification purposes only as marked in red on the attached plan ("the unauthorised structure")

4. REASONS FOR ISSUING THIS NOTICE

The Council consider it expedient to issue this notice for the following reasons:

The Council considers that the unauthorised structure has been erected within the last 4 years.

The unauthorised structure is considered to be contrary to policies DST2, DB7 and DH16 of the North Devon Local Plan as it is considered to be out of keeping with the character and appearance of the dwelling and has a detrimental impact on adjoining properties by virtue of its size, design, position and intrusion into privacy.

Planning conditions would not overcome the above reasons for issuing this Notice

The Council require that the steps specified in paragraph 6 be undertaken within three (3) months from the date when this notice takes effect.

6.	WHAT	YOU	ARE	REO	UIRED	TO	DO

1.	Dismantle	the	unauthorised	structure

- 2. Remove the unauthorised structure from the land
- 3. Remove all debris and rubbish resulting in taking the above mentioned steps.

7. WHEN THIS NOTICE TAKES EFFECT

This Notice takes effect on 10 September 2001 unless an appeal is made against it beforehand.
