#### THE BREACH OF PLANNING CONTROL ALLEGED

The unauthorised erection of a building in the approximate position shown by blue shading on the plan attached ("the unauthorised development")

#### **REASONS FOR ISSUING THIS NOTICE**

The Council consider it expedient to issue this notice for the following reasons:

1. In the opinion of the Council, the unauthorised development was constructed within the past 4 years

2. The unauthorised development is considered to be an inappropriate form of development in the countryside which in the absence of any overriding agricultural justification, is considered to be contrary to policy DST1 of the North Devon Local Plan and S4 of the Devon County Structure Plan First Review.

3. The unauthorisd development does not make adequate provision for the parking and/or manoeuvering of vehicles within the Land and would therefore be likely to encourage parking and/or manoeuvering on the highway with consequent risk of additional danger to all users of the road.

4. The Council does not consider that the use of planning conditions would overcome the above reasons for issuing this notice.
