# **ENFORCEMENT NOTICE**

## **OPERATIONAL DEVELOPMENT**

### TOWN AND COUNTRY PLANNING ACT 1990 (as amended by the Planning and Compensation Act 1991) ("the Act")

**ISSUED BY: North Devon District Council ("the Council")** 

**THIS IS A FORMAL NOTICE** which is issued by the Council because it appears that there has been a breach of planning control, under Section 171A(1)(a) of the Act, at the land described below. The Council consider it expedient to issue this notice, having regard to the provisions of the development plan and to other material considerations.

#### 2. THE LAND AFFECTED (shown edged red on the plan attached)

#### 3. THE BREACH OF PLANNING CONTROL ALLEGED

The erection on the land of a skate-board ramp shown in approximate position by blue outline on attached plan.

**REASONS FOR ISSUING THIS NOTICE** 

The Council consider it expedient to issue this notice for the following reasons:

The skate-board ramp is contrary to policies DST1, DST2, North Devon Local Plan as adopted, and policies ENV1 and DVS3 of the revised deposit of the North Devon Local Plan.

The development is deemed to be inappropriate development in the open countryside due to its affect on the visual amenities of the area and the detrimental affect on the living conditions of the neighbouring properties.

The erection of the stake-board ramp has occurred within the past ten years

Imposing conditions would not overcome the above reasons

#### 5. WHEN YOU ARE REQUIRED TO ACT

The Council requires that the steps specified in paragraph 6 be undertaken within the period of 4 weeks from the date when this notice takes effect.

#### 6. WHAT YOU ARE REQUIRED TO DO

1) Cease the use of the skate-board ramp

- 2) Remove the skate-board ramp from the land
- 3) Clear up any debris resulting from the above action.
- 4) Cease the use of the land for the erection of a skate-board ramp.

#### 7. WHEN THIS NOTICE TAKES EFFECT

This Notice takes effect on 10<sup>th</sup> March 2005 ("the effective date")\* unless an appeal is made against it beforehand.

One is for you to send to the Secretary of State if you decide to appeal. The other is for you to keep as a duplicate for your own records. You should also send the Secretary of State the spare copy of this Enforcement Notice which is enclosed.

WHAT HAPPENS IF YOU DO NOT APPEAL

If you do not appeal against this Enforcement Notice, it will take effect on the effective date and you must then ensure that the required steps for complying with it, for which you may be held responsible, are taken within the period[s] specified in the notice. Failure to comply with an Enforcement Notice which has taken effect can result in prosecution and/or remedial action by the Council.
