REASONS FOR ISSUING THIS NOTICE The Council consider it expedient to issue this notice for the following reasons:

The increased use of the access on to the public highway resulting from the use would, by reason of the limited visibility from and of other vehicles using the access be likely to result in additional danger to all users of the A361 road and interference with the free flow of traffic, contrary to the provisions of Policy TR10 of the Devon Structure Plan 2001-2016, Policy DT10 of the North Devon Local Plan and Policy TRA6 of the North Devon Local Plan Revised Deposit.


GUIDANCE NOTES FOR YOUR INFORMATION

One is for you to send to the Secretary of State if you decide to appeal. The other is for you to keep as a duplicate for your own records. You should also send the Secretary of State the spare copy of this Enforcement Notice which is enclosed.

WHAT HAPPENS IF YOU DO NOT APPEAL

If you do not appeal against this Enforcement Notice, it will take effect on the effective date and you must then ensure that the required steps for complying with it, for which you may be held responsible, are taken within the period[s] specified in the notice. Failure to comply with an Enforcement Notice which has taken effect can result in prosecution and/or remedial action by the Council.
