ENFORCEMENT NOTICE

MATERIAL CHANGE OF USE

TOWN AND COUNTRY PLANNING ACT 1990 (as amended by the Planning and Compensation Act 1991) ("the Act")

ISSUED BY: North Devon District Council ("the Council")

- 1. THIS IS A FORMAL NOTICE which is issued by the Council because it appears to it that there has been a breach of planning control, under Section 171A(1)(a) of the Act, at the land described below. The Council consider it expedient to issue this notice, having regard to the provisions of the development plan and to other material planning considerations.
- 2. THE LAND AFFECTED (shown edged red on the plan attached)

3 Silver Street, Barnstaple, North Devon

("the Land")

3. THE BREACH OF PLANNING CONTROL ALLEGED

Material change of use of the land to use for transport booking office, including taxi booking office, and tattoo studio.

4. REASONS FOR ISSUING THIS NOTICE

The Council consider it expedient to issue this notice for the following reasons:

It appears to the Council that the above breach of planning control has occurred within the last 10 years.

There is no adequate provision on the land for the parking of vehicles associated with the transport booking office. Consequently these vehicles park on the adjacent highway, which due to its inadequate width is unsuitable for such and results in congestion, danger to all road users and interference with the free flow of traffic.

Due to the hours of operation of the transport booking office, neighbouring properties are disturbed by the movement, parking and noise of vehicles calling at and leaving the land.

The lack of privacy of the activities associated with the tattoo studio has a deleterious affect on the amenity of neighbouring properties.

It is not believed that the above can be satisfactorily resolved by the use of conditions.

The Council require that the steps specified in paragraph 6 be undertaken within [the period of THREE (3) months from the date when this notice takes effect]

6. WHAT YOU ARE REQUIRED TO DO

- (i) Cease the use of the land as a transport booking office.
- (ii) Cease the use of the land as a tattoo studio.
- (iii) Remove from the land all equipment relating to the transport booking office.
- (iv) Remove from the land all equipment relating to the tattoo studio.
- (v) Clear up and remove all rubbish and debris resulting from taking the above mentioned steps.

7. WHEN THIS NOTICE TAKES EFFECT

WHAT HAPPENS IF YOU DO NOT APPEAL


