The Disabled Facility Grant programme has been included up to 2022-23 year (subject to annual confirmation of external funding from Better Care Fund).

There is no planned reduction to the funding level of Strategic Grants paid by North Devon Council for 2022-23 and maintains current funding levels; where there was originally a planned reduction outlined in the previous Medium Term Financial Strategy.

The proposed increase to Council Tax is across the whole district and is a neutral impact as this affects all the Council Tax payers.
