W H E R E A S the County Council of the Administrative County of Devon being the local planning authority for the said County are satisfied that it is expedient that the ~~particular~~ development specified in the Schedule hereto falling within Class IV.2 of the First Schedule to the Town and Country Planning General Development Order 1963 should not be carried out in the area of land coloured pink on the plan annexed hereto unless permission is granted on application in that behalf under the provisions of the said Order

N O W T H E R E F O R E the said Council in pursuance of the powers conferred upon them by Article 4 of the Town and Country Planning General Development Order 1963 hereby direct that the permission granted by Article 3 of the said Order shall not apply to the ~~particular~~ development specified in the Schedule hereto in the said area of land

T H E S C H E D U L E

Class IV.2 - The use of land (other than a building or the curtilage of a building or the site or curtilage of a building which has been demolished in consequence of war damage) for any purpose except as a caravan site on not more than 28 days in total in any calendar year and the erection or placing of movable structures on the land for the purpose of that use
