WHEREAS the County Council of the Administrative County of Devon being the local planning authority for the said County are satisfied that it is expedient that the development specified in the Schedule hereto falling within Class VI.1. of the First Schedule to the Town and Country Planning General Development Order 1963 should not be carried out in the area of land coloured red on the plan annexed hereto unless permission is granted on application in that behalf under the provisions of the said Order  
NOW THEREFORE the said Council in pursuance of the powers conferred upon them by Article 4 of the Town and Country Planning General Development Order 1963 hereby direct that the permission granted by Article of the said Order shall not apply to the development specified in the Schedule hereto in the said area of land

THE SCHEDULE

Class VI.1. - Agricultural buildings works and uses

The carrying out on agricultural land having an area of more than one acre and comprised in an agricultural unit of building or engineering operations requisite for the use of that land for the purposes of agriculture other than the placing on land of structures not designed for those purposes or the provision and alteration of dwellings

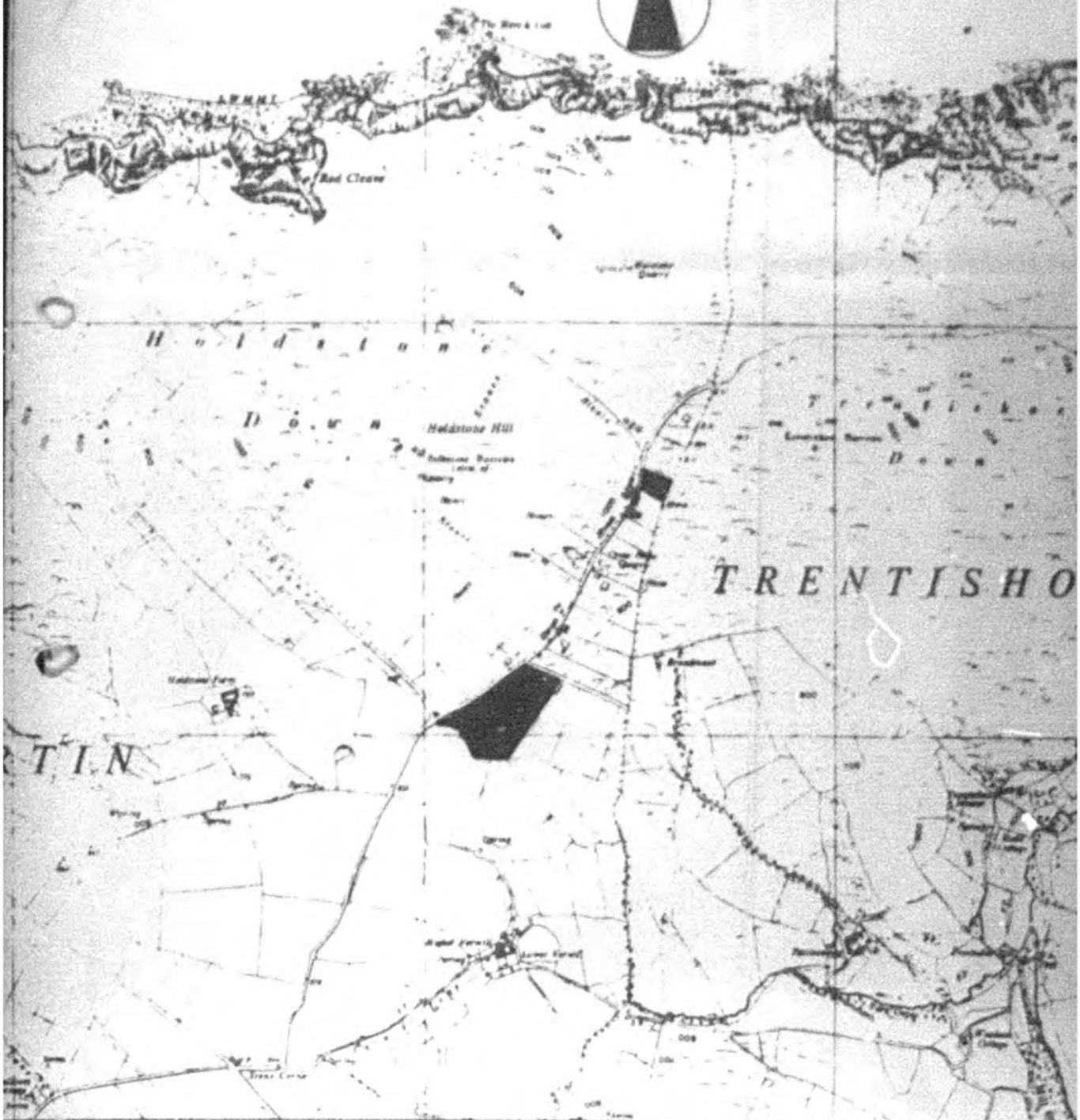
