

THE NORTH DEVON (OFF-STREET PARKING PLACES) (AMENDMENT) ORDER 2021

The NORTH DEVON DISTRICT COUNCIL in exercise of its powers under Section 35 and Section 35(A) of the Road Traffic Regulation Act 1984 (“the Act”) and Part IV of Schedule 9 to the Act as amended by the Parking Act 1989 and Part 6 of the Traffic Management Act 2004 and The Civil Enforcement of Parking Contraventions (Guidelines on level of Charges) (England) Order 2007 and of all other enabling powers, with the consent of the County Council of Devon in accordance with Section 39(3) of the Act and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1. This Order may be cited as the North Devon (Off-Street Parking Places) (Amendment) Order 2021 and shall come into operation on the date that this Order is signed.
2. This Order shall amend the North Devon (Off-Street Parking Places) Order 2019 as amended by the North Devon (Off-Street Parking Places)(Amendment) Order 2019 (“the Existing Order”) only so far as contained herein.

Amendments to the Existing Order shall be as follows: -

Schedule

The Schedule shall be amended to include:-

1. The addition of ‘D7’ which means 1 July – 31 August plus 28 ad hoc days.
2. The addition of ‘V22’ which means No Horseboxes.
3. ‘C48’ means 20p for the first 20 minutes, 70p up to 1 hour, £1.40 up to 2 hours and £2.20 up to 3 hours. Each additional hour will be 50p.
4. ‘Jubilee Gardens – Theatre Reserved’ shall be removed from the Schedule.
5. Lynbridge Permit shall be removed.
6. ‘South Molton car parks’ shall be renamed to ‘South Molton Central’



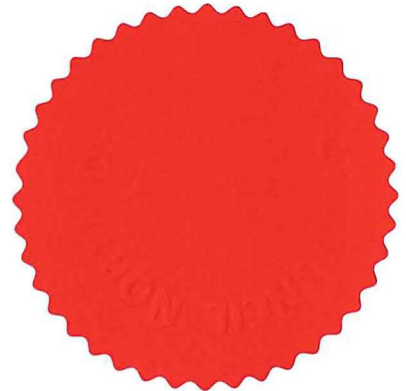
